VII. NEW BUSINESS

A. **Utility Building Break-Ins**. The Manager recommended that the Utility Building exterior doors, from the pool to the Meeting Room and from the alley to the Laundry Room, be secured by a card entry system. Bids will be obtained and submitted for Board review and approval. A maintenance Room Break-In occurred on 11/26/2021 and a Restroom Break-In on 12/05/2021.

B. **HVAC Generator Lease**. Jeff Hughes moved that we accept the generator lease from Daikin for December 20, 2021, through February 28th, 2022 as potential freeze damage protection. The projected cost is \$35,225, with an operating expense between \$5,500 and \$7,500. The generator will supply power to the HVAC boilers, pumps, and motors to keep hot water circulating in the pipes to protect against freezing. It will not provide power to the condos. Darrell Traeger moved that the motion be tabled until further research can be provided. The motion was tabled.

C. **Appointment of Nominating Committee**. Jim Eason was appointed as Chairman of the Nominating Committee for the 2022 year. He will ask 2 non-board members to participate.
