



Chiller Replacement and Electrical Upgrade 2018

The replacement of chillers and electrical upgrade approved for this year will begin, **weather permitting**, on February 5th and be completed on February 23rd. The total cost of the project is \$560,000.00 and is being financed with a 5-year loan, secured in part by CDs, through North Dallas Bank and Trust.

The electrical upgrade will be first and is scheduled to take one week during which **the electricity for the entire community will be off for 8 hours on a Monday, February 5th and another 8 hours the following Friday, February 9th.** The domestic hot water will be off when the power is off on Monday and Friday ***There will be no (HVAC) heating or cooling for the entire week.***

Following the electrical upgrade, the chillers will be replaced. This is scheduled to take two weeks beginning on Monday, February 12th and concluding on February 23rd. **During this time the air conditioning will not be working, but heating will be available as needed.**

Please bear with us as these required improvements are taking place. The timing of the work may change if the weather is too cold on the planned dates. **Schedule changes will be sent as needed through VoiceFriend.**

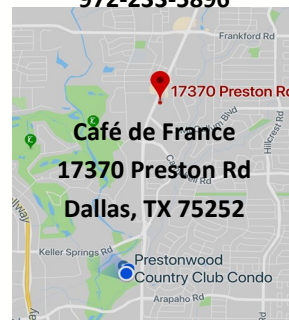

Happy New Year! Ways to Be Safe in 2018



A new year is upon us and your Crime Watch and community are still on duty helping us to make 2018 safe and happy!

*Always lock your cars day and night. GPS and other electronics, wallets, credit cards, phones and purses are being stolen late at night or even in the day. Even if car is locked, don't leave items visible in your car.

*Credit card scanners are still being used in drive-in gas station pumps installed inside the credit card slot. There is a gang operating in Dallas and outlying areas. Credit card numbers have been stolen at Exxon drive-ins at Hillcrest and Arapaho, the store at Arapaho close to Central, plus one on Preston Rd. Before inserting card run a heavy piece of paper or index card just inside the slot. If you feel a lose piece of equipment inside the card entry, report it immediately to clerk inside drive-in. **Never press debit button to pay for gas.**

*Avoid ATM machines at other sites rather than banks. Bank of America ATM found a scanner in convenience store location that accessed customer bank accounts.

*Police advise not making late night or early morning runs to ATM's as these are perfect times for criminals to pounce!

*Female walkers on area trails being harassed by male driving white Tahoe. Police have had many reports of this, but can't get there in time. Carry your phone and walk with buddy. As soon as Creepy Man sees you put phone to ear, he makes fast getaway!

*Scooter and motorcycles being snatched in Prestonwood residential areas and Chalfont Place.

*IRS ominous messages left our phones are "**robo calls.**" The crooks don't have your specific phone number or name **UNLESS YOU CALL THEM BACK ON THE NUMBER THEY LEAVE ON MESSAGE.** Delete message immediately! The IRS, Dallas Police/Firefighters/Sheriff's office/State Troop charities or Dallas Jury Department never communicate by phone—always by letters not phone!

***Unauthorized or abandoned vehicles will be towed from our community parking lots.**

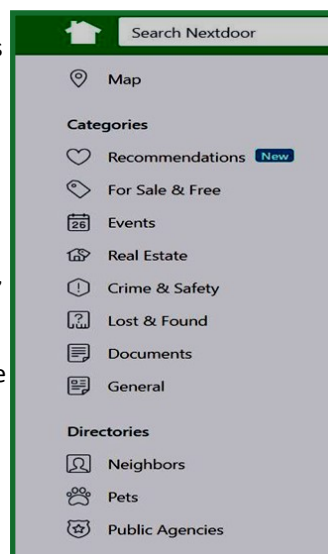


CONNECT WITH YOUR NEIGHBORS

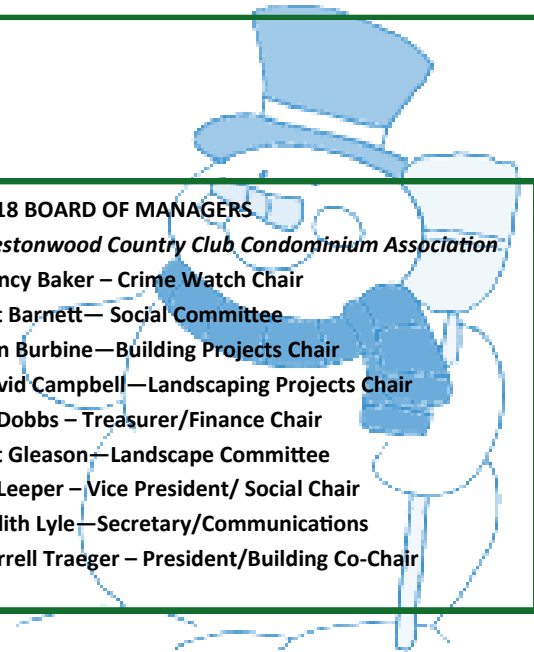
