GETTING TO KNOW YOUR BOARD



The Board of Managers of the Prestonwood Country Club Condominium Association consists of nine individual condo owners who volunteer their time and individual skill sets to manage and govern the affairs of the Association.

Reminder of Community Rules—Complete copy @ www.pwccca.org. Please be aware.

PETS -The following rules are to be as restrictive as possible while not violating the Fair Housing Act (State and Federal), the Americans with Disability Act, or any similar laws which may be amended from time to time. Any resident/Owner who keeps a pet on the condominium property shall be deemed to have indemnified and agreed to hold harmless the Board, the Association and other Owners and residents from any loss, claim or liability of any kind or character whatever resulting from any action of his or her pet or arising by reason of keeping or maintaining such pet. Subject to these laws:

PERMITTED: Residents may keep one (2) house pet inside the unit:

Domesticated dogs and cats. Caged birds. Aquarium fish. Animals that serve as physical/mental/emotional aid to handicapped persons.

PROHIBITED:

Dangerous or exotic animal, or any other animal deemed to be a potential threat to the wellbeing of people or other animals. [Dallas City Code SEC. 7-5]

Breeding or raising animals for commercial purposes.

Noises from an animal for longer than 15 minutes. [Dallas City Code Sec. 7-4.8]

Any pets within the swimming pool enclosure

REQUIREMENTS:

PICK UP YOUR PET'S POOP. [Dallas City Code SEC. 7-4.8]

PET DAMAGE: Each Owner is responsible for any property damage, injury or disturbance caused by a pet residing in their unit.

Call 311 to report an animal problem and follow up with an online letter. You will get an email back, stating that Animal Control will investigate.

Helpful tips from Nancy Baker PWCCCA Homeowner and Crime Watch/Safety Chair



The majority of our homeowners know and obey our security safeguards for dogs and owners as outlined in our condominium rules. We need your help in cooperating with Dallas Police and Dallas Animal Control in reporting all loose and unleashed dogs in our common areas and the adjoining green belt. As you may have heard in the news, loose dogs running in our streets have become an increasing danger for Dallas citizens.

Since one of our residents and her leashed dog were attacked recently, we are working with proper authorities to protect all of us from dangerous dog encounters. If you witness any loose dogs, call 311 for Animal Control or 911 if an attack is occurring. Unleashed dogs are against city ordinances, are eligible for city fines, and/or some more aggressive dogs will be removed by

Animal Control officials. Here are a few suggestions to keep us a "pet and people" friendly community:

*Dogs are to be leashed whenever they are outside especially in the alley. Alleys are used only by the residents who share that individual alley. Residents are not allowed to walk their dogs down any other alley except their own.

*Exercise good "dog" manners by not letting your pet rush over to sniff and greet other dogs and owners you don't know. Dogs are like us—there are some they don't like!

*Always Pick Up Your Dog's Poop! Use the dog refuse and bag stations to keep our grounds clean up - it is a must for community cleanliness, health, and beauty

We take pride in our homes and being a pet friendly community! It takes cooperation from everyone to achieve this goal! Please take time to read your condominium rules and be in the know for peaceful living with our families which include our children and grandchildren.

****Alert from next door Chalfont Place Crime Watch. There has been an increase in aggressive panhandlers begging for money outside local restaurants and nearby streets. Be aware of your surroundings.

SUMMERTIME POOL SAFETY

SWIMMING POOL—NON-SMOKING AREA

Hours 8am – 11pm daily

No life guard - Swim at your own risk.

Non-swimmers and children under 13 must be accompanied by an adult

Pool is for the exclusive use of residents and their guests.

Residents must accompany any guests.

Prohibited:

Glass containers, Pets, Cooking within Pool Area, Loud music or other noise that is disturbing (whether such loud music or other noise is disturbing shall be determined in the Board's sole discretion), Pressurized water toys, Inflatable rafts, boats, etc. that exceed 30"x72"
