CAPITAL IMPROVEMENTS

Good news! Your property elves have been working on critical infrastructure requirements to keep our homes comfortable in the ever-changing Texas climate.


HVAC - The association has a Four-Pipe heating, ventilation and air conditioning system (HVAC). Boilers, chillers, cooling towers and pumps are the components that produce and deliver heated/chilled water from our utility building at the pool through underground pipes into each condominium's fan coil units where a fan blows across the coils to provide heat and air conditioning. During 2015, extensive research was done by a Board of Managers special committee to determine the best path to upgrade our aging plant. These necessary major improvements and repairs are nearing completion and include:

- Replacement of the boilers which were installed in 1995 and were well beyond the warranty period
- Major renovations on the two chillers which were installed in 1995
- Repairs that were made in the 2 cooling towers
- Replacement of pumps that distribute the chilled water
- ♦ Replacement of the pumps for heated water will be replaced as weather permits

 Hot Water The PWCCCA domestic hot water boilers have also been replaced. The typical life expectancy is 12 years; the existing boilers had been in service for 15 years and had developed leaks. These boilers provide water for your shower, dishwasher, faucets and anywhere else hot water is needed.

Association Reserve Funds which have been saved over the past 3 years and were largely funded by the assessment increase in January 2016 are held in Certificates of Deposit. This critical project was funded by borrowing against the CD's which made these upgrades possible without liquidating any Association assets or imposing a special assessment on condominium owners.

Early next year, homeowners will be invited to tour the facilities for a first-hand look at the new equipment and how it impacts you every day.

JUDITH LYLE, Board Secretary and Communications Chair




