Β. BUILDING COMMITTEE- Darrell Traeger: Discussed building remodels that are not being completed on time and the importance of the Renovation Policy to help move projects along in a timely way. Discussion of an electrical problem with a washer and dryer installed in a unit on Coolwood. The electrical was hazardous from a previous installation and the issue had to be fixed correctly which involved the association funds. The renovation policy will prevent this kind of issue as inspections of all units sold will be necessary. Darrel also discussed that outdoor washer and dryer hookups exit which must be corrected to be in compliance with building codes. On July 13 paint fumes from a unit became overwhelming to other residents of a building on Stillwood. Darrell was called to check it out. There was a discussion regarding toxic fumes. The Renovation Policy prohibits Noxious Fumes. On July 17, 18 an ongoing issue with disturbing noise was reported. The resident offender's owner is being fined. On July 21 there were reports of non- residents using the pool. No action was taken. Recommendations were made to board members and other owners to report misuse of the pool by nonresidents and including other pool infractions: use of bottles, cigarette butts all around, chairs in pool, and people fully clothed in the pool. Take pictures with your phone and send to the office. On July 22 Carrie and Darrell checked out a unit that the resident reported high temperature in one of the rooms where it was deduced that little or no insulation was present. Although the board is compassionate to the resident's issue no action can be taken by the board at this time. Darrel stated that this is another reason to have the Renovation Policy in place. Darrell discussed action to be taken on a unit (uninhabited) on Stillwood that has not paid dues

since 2014. Darrell moved that the board spend the money \$200-\$500 dollars for a full title search on this property. Joe Dobbs seconded. Motion passed unanimously.
