#### **RECITALS:**

- 1. On or about June 10, 1977, that certain instrument entitled "Condominium Declaration for Prestonwood Country Club Condominiums (A Condominium)" was duly recorded in Volume 77112, Page 0006, et seq. of the Condominium Records of Dallas County, Texas (the "Declaration") thereby creating the Prestonwood Country Club Condominium.
- 2. Article IV, Section 3 of the Amended and Restated Bylaws of Prestonwood County Club Condominium Association, Inc., which were attached to the "First Supplement to Notice of Filing of Association Instruments" recorded in the Official Public Records of Real Property of Dallas County, Texas under Clerk's File No. 20080116736 (the "Bylaws"), provide that the Board of Managers shall have all the powers and duties granted the Board under the Bylaws, Declaration, and state and federal law, including but not limited to establishing, making and enforcing compliance with such reasonable rules and regulations as may be necessary or suitable for the operation, use and occupancy of the condominium project with the right to amend such rules from time to time.
- 3. Article IV, Section 3.b. of the Bylaws further provides, that the Board of Managers has the authority to establish, make and enforce compliance with reasonable rules and regulations as may be necessary or suitable for the operation, use and occupancy of the condominium project with the right to amend same from time to time.
- 4. Secondhand smoke from tobacco products, electronic cigarettes, and "vaping" can create a nuisance to the residents of Prestonwood Country Club Condominium.
  - 5. Studies have shown that secondhand smoke can be hazardous to one's health.

6. The Board of Managers desires to adopt a policy prohibiting the smoking of tobacco products and electronic cigarettes of any type and "vaping" in certain areas of the general common elements of Prestonwood Country Club Condominium.

### **RESOLUTION:**

BE IT RESOLVED, that the following No Smoking Policy is hereby adopted:

The smoking of tobacco products and electronic cigarettes of any type and "vaping" is prohibited in the swimming pool area, the laundry room, the community meeting room (also known as the club room), and the community restrooms within Prestonwood Country Club Condominiums.
